- Introductions

~~ Trail Committee Members present: Mark Michel, Miguel Galeana, Courtland Capwell.

- Meeting scope and duration

~~The agenda was reviewed.

- Trail Status Update

- 360

~~ New Trails Completed: Quick Release, Jump lines.

~~ Trails under construction: Jump lines, Nick Marvik's Advanced Bike line.

~~ Proposed New Trails: Courtland would like to build a "primitive" single-track cross-country trail near "Quick Release." He explained the new trail would increase safety for pedestrians wishing to hike in the same area as Quick Release.

~~ Courtland would also like to develop a trail on the southeast perimeter of 360 Trails. This trail would capitalize on newly acquired property and serve as a connection from the old (current) 360 Trails parking lot to the west bridge from Gateway. This trail would be a primitive bike and pedestrian trail.

~~ Mark reported speaking with Nick about the bike line's proximity to the west property line (where the equestrian perimeter trail had been proposed). Nick reported that during construction the trail is significantly wider than necessary and can be modified to allow an equestrian trail to be built between the bike trail and the property line. In future discussion with Scott Gallacher, he said the two paths could be separated by fencing if necessary.

- Gateway Plans

~~ Committee members reviewed Gateway Plans. Discussion included timing of Phase I construction, amenities, and potential for staging events in the future. Miguel believes Gateway and the adjacent 360 Trails can be ideal for large events. Courtland and Miguel said large, 24 hour events are very popular and expressed a desire to have camping/overnight events staged from Gateway.

- 480 (Key Central Forest)

~~ Mark presented the existing trail map for Key Central Forest. Committee members expressed enthusiasm over connecting existing spur trails to form loops - as previously considered. Miguel expressed a desire to see the property as his time allows.

- Transfer Station

~~ Proposed and flagged pedestrian trails at the transfer station lease property were discussed.

- Adjournment

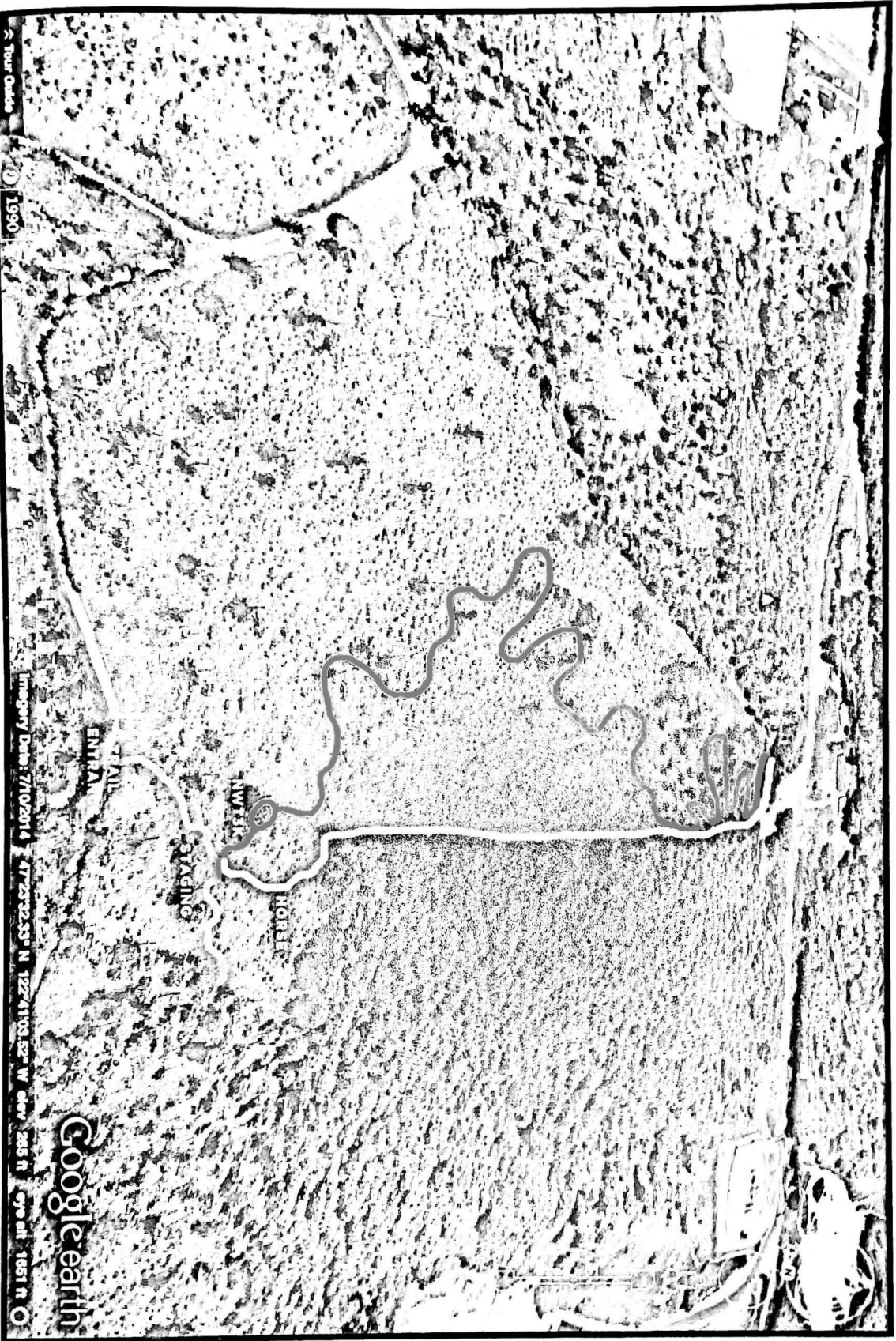
