- **3. Unfinished Business/Park System Comprehensive Plan 2014-2019:** Addressed to date "Guiding Principles for KPP Operations", "Goals and Objectives", "Park Facilities Inventory", "Park Facilities Matrix", "Key Peninsula Map", "Park "Survey", "Survey Results", and "6-Year Capital Improvement Plan". Plan elements remaining are the "Introduction", "Funding Strategies", and "Demand and Needs Analysis/Level of Service". The Board noted that the RCO's definitions for "passive recreation" and "active recreation" were significantly different from KPP's; consensus was to add a "Definitions" element to the Park System Plan. Definitions were discuss and agreed upon.

Discussion regarding the "Demands and Needs Analysis/Level of Service" was begun. There was general agreement that Key Peninsula North lacked multi-use lighted fields and that the general public supports a north-south trail system. Executive Director Gallacher was instructed to get examples of this park system plan element from other park districts which are similar in size and composition and e-mail them to the Commissioners. The Board will address this element, in addition to the "Introduction" and "Funding Strategies", at the Feb. 10, 2014, meeting.

Final approval of the updated Key Peninsula Park System Plan 2014-2019 will take place at a special meeting on Monday Feb. 24, 2014; to qualify for the upcoming RCO grant funding cycle the Key Peninsula Park System Plan must be approved before March 1, 2014.
