The regular meeting was preceded by a 6:30 PM study session. Executive Director Gallacher reported that he is meeting with school district personnel regarding a live-on-site caretaker/gatekeeper for Volunteer Park and KP Middle School. Commissioner Robison asked about long term tracking for the Gateway Park state grant requirements; he requested that such a document be created. The Key Peninsula Historical Society requested permission to relocate a donated historical farm house to Gateway Park; Executive Director Gallacher informed the Board that the Gateway Park RCO purchase grant would prohibit that though the building could be stored there temporarily. He said that the Gateway Park/Manke Acquisition expansion, potentially funded through a Pierce County Conservation Futures grant, has a designated area for KP Historical Society use. The Board suggested the KP Historical Society research other short term storage options for the farm house (2 stories with a 16'x24' footprint) pending Key Pen Parks acquisition of the Manke A and B properties.

The public meeting was called to order at 7:30 PM in the Volunteer Park Office by President Michel; Executive Director Gallacher left close to 7:00 PM to catch a flight for a NRPA conference. Commissioners Present: Mark Michel, Bill Trandum, Ed Robison, John Kelly, and Kip Clinton. Staff present for Key Pen Parks: Executive Director Scott Gallacher left close to 7:00 PM for the NRPA conference, Administrative Assistant Laura Armstrong.

Citizens present: Paul Michaels, Claudia Jensen, Shawn Jensen, Susan Quigley, Christine Anderson, and Stan Moffett.

Pledge of Allegiance: Recited.

Approval of Agenda: Agenda approved as submitted.

## **Business Meeting**

- 1. Minutes: President Michel asked if there were any objections or corrections to the August 10, 2015 meeting minutes; hearing none, the meeting minutes were approved as written.
- 2. Financial Report: The August 2015 BIAS Financial balance was \$2,381,132.17. The Zoo Trek August deposit was \$13,646.82. Total Zoo Trek collections to date were \$95,293.99. August's Real and Personal Property Tax and delinquent property tax collections were \$4313.29. Total 2015 Real and Personal Property Tax collections to date were \$490,891.24. Expenditures for August 2015 were \$64,315.48. Commissioner Michel asked if there were any corrections or objections to the August financial report, hearing none, the financials were accepted at submitted.
- 3. Staff Report: Covered in study session.
- 4. Board Committee and Advisory Council Reports:
- **a.** Land and Improvement Committee (Commissioner Robison): Commissioner Robison stated that he has been getting appraisals done so that the Park District can make a submission to Manke for the purchase of the Manke Property. He stated that the Park District is also awaiting a response from Pierce County Conservation Futures to see if we will be awarded grant funding.
- b. Key Peninsula Park and Recreation Foundation Report (Commissioner Trandum): Commissioner Trandum stated that the Foundation has laid out a fundraising plan to support the building of a playground at Gateway Park. Foundation President Susan Quigley stated that they have a new website going up, October 1<sup>st</sup>, with a big fundraiser commencing in October.

- c. Trail Updates (Commissioner Michel): Commissioner Michel stated that the 36@360 Mountain Bike Race will be held on Halloween this year. He also stated that during negotiations with TPU regarding Power Line Road/144<sup>th</sup> St. KPN trail access he found a new contact person; Commissioner Michel reached out to one of the TPU commissioners about attaining a 2.6 mile trail easement between 360 Trails and Rocky Creek Conservation Area. The Key Central Forest Western Access Road just got built into the DNR 480 property (Key Central Forest).
- d. Recreation Committee (Commissioner Kelly): No report.
- 5. Board Presidents Report: No report.
- 6. Unfinished Business/ Gateway Park Master Update: Covered in staff report.
- 7. Unfinished Business/ Resolution R2015-06 Employee Handbook Revision: Commissioner Robison made a motion, "That we adopt Resolution R2015-06 adopting the employee handbook as edited." Commissioner Clinton seconded, the motion was passed 5/0.
- 9. New Business/ Allowing Commissioner Clinton to be spokesperson on Pierce County Conservation Futures issue to Pierce County Council: Commissioner Robison made a motion; "That we appoint Commissioner Clinton to be our official spokesperson on the Pierce County Conservation Issues to Pierce County Council." Commissioner Trandum seconded, the motion was passed 5/0
- 10. Other minor matters: none.
- 11. Commissioners Comments/Good of the Order: None.
- 12. Meeting Adjourned: The public meeting of September 14, 2015, was adjourned at 7:41 PM. The October meeting will be held at 7:30 PM on October 12, 2015 and will be preceded by a 6:30 PM study session.
