Whereas the Key Peninsula Metropolitan Park District is a newly formed municipal corporation and has no existing small works roster/vendors list;

And whereas the Key Peninsula Park and Recreation District, and existing Park and Recreation District, has an existing small works roster/vendor list;


And whereas the Key Peninsula Metropolitan Park District will be assuming all responsibilities and acquiring all assets of the Key Peninsula Park and Recreation District;


